## *AHEPA 528 Minutes 6/12/23*

The June 12th meeting was called to order by AHEPA 528-chapter President Wynn Storton. Members also present included the V. Rev Fr. Ted Pantels, Vice Presidents Nick Krespis and Nick Andros, Treasurer Kyriakos Seraphim, Bill Rellos, and Matt Holm.

Attendees on Zoom included current District Governor Nick Angelos, Ramsey Seikaly, and Harry Loukatos.

The meeting was called to order at 6:35 PM and Fr. Ted opened the meeting up with prayer.

District Governor Nick Angelos is optimistic about the future of AHEPA and congratulated those who attended the District 20 Convention.

AHEPA Chapter 528 President Wynn Storton discussed the idea of a “free AHEPA Membership” for a TBD time period that could be extended to AHEPA Scholarship awardees. More on that to come as details emerge.

The District 20 Mid-Winter Conference will be in Long Beach Location and date TBD.

AHEPA 528 Brother Matt Holm was informed that he was the recipient of the District 20 “AHEPAN of the Year” award.

Currently AHEPA Chapter 528 has 34 Members and five individuals who are inquiring about membership. President Wynn Storton asked each brother to set a goal to recruit one new Member a year.

Treasurers Report was read as submitted by Riakos Seraphim. The Chapter is financially sound.

Outreach programs in place are the “Narrow Door” and various forms of giving to both St. George Church and St. George Philoptochos. Plans were discussed about doing some “touch up” painting at St. George to the exterior “blue metal” surfaces as a means to beautify the church grounds and enhance brotherly fellowship. (Possibly October)

An AHEPAN run “Greek Dinner” was discussed with a tentative date of Saturday, September 30th of this year.

A \$500-dollar Supreme Convention “Ad” was voted in unanimously. (Motion M. Holm; 2nd by N. Krespis) As a reminder the convention will be taking place in Las Vegas, NV from July 23rd to the 29th.

There are no meetings taking place in July or August.

The meeting was adjourned at 8:05 PM.
